

INTRODUCTION

EFB PORTRAIT

BACKGROUND

The European Fund for the Balkans was established in June 2007 as a multi-year joint initiative of European foundations including Robert Bosch Stiftung, King Baudouin Foundation, Compagnia di San Paolo and ERSTE Foundation.

The Fund is designed to undertake and support initiatives aimed at **bringing the Western Balkans closer to the European Union** through grant-making and operational programmes and as such is focused on individuals and organisations from the Western Balkans region.

As a direct follow-up to the International Commission on the Balkans (2004-2006), the Fund embodies the *"member-state building strategy"* which includes the *development of functioning state administrations* and *constituency-building* as main priorities.

OBJECTIVES


More specifically, the Fund's objectives are:

GRANTMAKING

The European Fund for the Balkans issues calls for proposals that seek to generate innovative and promising ideas from the people and organisations from the Western Balkans. Unsolicited proposals are not accepted. The Fund supports projects that are in line with its priority programme areas by issuing calls for proposals throughout the year.

PUBLIC PRIVATE PARTNERSHIP

The venture is designed to engage not only European funders already active in the Balkans, but also public and private donors who have not worked in the region until now, or wish to leverage their own funding and increase its impact.

STRUCTURE

The Fund is managed under the authority of a Steering Committee, which is responsible for the strategic orientations of the Fund and oversees the work of the Secretariat. The Steering Committee is the official decisionmaking body of the Fund. Each of the foundations constituting the Fund has one representative in the Steering Committee.

The Belgrade-based Secretariat, led by the Executive Director serves as the Fund's headquarters.

The European Fund for the Balkans was established by four private European foundations as a follow-up to the work of the International Commission on the Balkans (2004 – 2006). This way, the Fund represents putting into practice the recommendations of the Commission to accelerate the process of the Balkan EU membership so as to guarantee political and economic stability in Europe. Being shaped by the Commission's heritage the Fund has a clear framework and a serious and influential backing. The Fund aims to bring the Western Balkans closer to the EU through programmes and activities focused on 'member-state building' and pro-European constituency building. Operating in all Western Balkans countries by implementing a unique programme strategy makes the Fund a regional actor and partner to different stakeholders and an active promoter of cross-border and regional co-operation. Until this date, a valuable network of different governmental and non-governmental organisations, institutions, groups, initiatives, and individuals got engaged with the Fund and its activities, from the region and beyond.

The activities carried out during the first 3 years followed a step-by-step approach articulated along four main programme areas: Envisioning Europe, Practicing Europe, Experiencing Europe and Supporting Policy Development. Additional activities have been developed around flagship annual programmes, creating thereby links and synergies between the different programme strands.

This report is not an attempt for summarising the achieved results of the Fund. It is a colourful presentation of the main images and impressions from the past 3 fruitful years of EFB. It shows people who are in the heart of the Fund's existence; moments that were special; words which give us feedback and make us even more motivated for meeting the future challenges.

Building up an initiative, as ambitious as the European Fund for the Balkans, requires a special set of conditions and resources. These prerequisites, some of them mentioned above, made the Fund possible and existent. However, without key individuals involved and their immense personal commitment, it would have never become what it is today. The EFB addresses the need for strengthening of administrative capacity through its **Fellowship Programme for Young Government Officials**. In addition, the EFB considers enabling **increased regional cooperation** between public administration officials from different government institutions of Western Balkan countries as one of its priorities in the upcoming period.



The Commission will continue to pay close attention to the existence of professional and functioning public administration. It will further encourage the exchange of best practices and the sharing of expertise between countries in the field of public administration reform.

to Union-based standards. Hence, the timing for a Governmental professional of the EU acceding country having a flavour of a wellfunctioning mechanism was perfect. We have been able to learn more about German legislative activities in different areas of our interest as well as of their best legislative solutions. 



Supporting independent think-tanks is not a shortcut to the immediate progress, but a strategic move for long-term improvement of policy processes in the Western Balkans. Though no cureall, these independent centres of knowledge are helpful agents in promoting new ideas and monitoring implementation of the adopted reforms. With the European Union programs and national governments focused on service provision organizations and bilateral donors engaged in the government capacity building, empowering capacity for the independent policy analysis through think tanks is crucial. Private foundations and like-minded donors should step up their efforts

instead of graduating this type of organizations from their support. After all, think tanks and donors share a joint goal in the region - influencing and mending the often broken down policy process.

The European Fund for the Balkans, although a "new kid on the block" has quickly found a particular niche among the "bigger donor-brothers". Two particular efforts stack out. First, Its "Think and Link - Regional Policy Program" has become a useful vehicle for supporting a niche policy research. Most of this policy research was carried out by a new generation of think tanks in the region. A school for talented young people – many returnees from respectable western universities – has created a new wave and provided unprecedented levels of modern and relevant policy research in the region.

Second, without the EFB support, the Gallup: Balkan Monitor would not have existed. The EFB enabled Gallup to provide the region's policy analysts, researchers, journalists and many more with excellent, comparable data each year. This data provided in user-friendly format online helps many people to identify some national trends, but also to compare those between the countries and across different years. In one word, the survey has become an essential tool in the hands of many people in the region.

EXPERIENCING EUROPE [OVERVIEW]

In the Western Balkans social capital is dispersed and fragmented and all political ideas have been exhausted. The young generations in the countries of the region appear insufficiently involved in the reform process. These future leaders face very similar problems, across the region and it is given that they should search for the solutions and answers to some of the questions regarding the development of their societies - **TOGETHER**.

They see their countries' accession to the EU as the only way to fulfil their life expectations and enjoy the opportunities their peers in the EU member states have. Most young people in the Balkans perceive rule of law, economic progress, social security, and political stability as a chance for better life and future. The Balkan societies have, however, reformed their political and economic systems only partially. The system of corruption which compromises political elites and life in the countries which do not offer equal opportunities to all have made the young, the most progressive parts of the society, the advocates of positive social values and Euro-enthusiasts, feel as outsiders in their own homes, as marginalised social groups deprived of political power and influence on the society.

Bearing all of the above in mind, the EFB has identified the continuation of the **Leadership Development Programme**, aiming at gathering and empowering young leaders, and thus addressing some of the issues identified above, as one of its priorities.

The Leadership Development Programme was launched in 2006/2007 by the College of Europe and the TRANSFUSE Association. The European Fund for the Balkans began financing the programme in 2008 and since 2009 is organising it jointly with the College of Europe and the TRANSFUSE Association.

30 graduate students from Albania, Bosnia Herzegovina, Bulgaria, Croatia, Macedonia, Greece, Kosovo, Moldova, Montenegro, Romania, Serbia and Turkey are selected each year to take part in the 8 month long 'Southeast Europe and the EU - Leadership Development Programme'. A limited number of participants are selected from other European countries. The LDP is led by an Academic **Dean** who guides the participants through the different elements of the program.

GALLUP Balkan Monitor Insights and Perceptions: Voices of the Balkans

The European Fund for the Balkans formed a partnership with Gallup Europe for launching the "Gallup Balkan Monitor", which aims to provide all-encompassing data on people's perceptions in the Western Balkan region, creating thereby a one-stop shop that delivers strategic insights based on evidence-based social research in the region. Covering Albania, Bosnia and Herzegovina, Croatia, Kosovo, Macedonia, Montenegro, and Serbia, the Gallup Balkan Monitor asks more than 100 general and country-specific questions and explores a series of key issues including: social & economic conditions, employment prospects, business conditions, attitudes and perceptions about the EU and international community, good governance, corruption, crime & safety, political activity in the region, ethnic & cultural identities and perceptions of other ethnic groups, religion, well-being & life satisfaction, migratory patterns and the future: outlook and aspiration. The research is conducted annually, thereby providing an up-to-date assessment on the socioeconomic, sociopolitical, and multicultural dimensions of the Balkan region.

Balkan-Monitor.eu provides news and views about the Western Balkans. This is a one-stop-shop for anyone requiring strategic insights into the Balkans.

In order to present and widely acknowledge the results of the Gallup Balkan Monitor, the EFB in cooperation with Gallup Europe organizes the series of the Gallup Balkan Monitor presentations and the public discussions in the capitals of the Western Balkan countries, where the results are presented and discussed with the leading analysts, journalists, government officials, academics, representatives of the CSO and think tanks from the region. The results will serve as a basis for the discussions on the future of the Balkans, its European aspirations and the potential for "attitude change" and europeanization of the societies in the region.

7 events are organized in the capitals of the Western Balkan countries every year. The roadshow events are accompanied by the campaigns with the most interesting results in each country where the roadshow event takes place.

The discussions are organized in Zagreb, Belgrade, Sarajevo, Skopje, Podgorica, Pristina and Tirana.

The results of the first wave of the survey were presented in November 2008 and thereafter distributed all throughout the region, at the policy discussions held in every Western Balkan capital. The second survey of the Gallup Balkan Monitor was presented in November 2009 and was subsequently distributed throughout the region, December 2009 – March 2010. A new wave of the survey is on its way for 2010.

ROBERT MANCHIN CHAIRMAN AND MANAGING DIRECTOR GALLUP EUROPE

I ran the first Gallup survey in what is now called the Western Balkans in 1989 and have been monitoring changes in this dynamic and multi-faceted region ever since. Given the radical, too often violent transformations the region went through after my first assignments there I regretted that there was no continuous large-scale survey reflecting the opinions and emotions of the Western Balkan people. It is Gallup's mission to "let people be heard" – in the case of the Balkans giving the populations a voice is a vital step for understanding of this part of Europe, for self-reflection and, finally, for being able to communicate about possible future directions as well.

In the European Fund for the Balkans, founded in 2008, Gallup then met an ideal partner for creating a unique information source based on sound and Comparative measurement of social changes in the Balkans, accessible to all the stakeholders. The EFB had the necessary ambition and enthusiasm to partner with us in a survey that has become the Gallup Balkan Monitor. Together, the EFB and Gallup have given a voice to a whole region, and have tirelessly transported the region's people's message in many reports, presentations, panel discussions and meetings with decision-makers, in the Western Balkans and beyond. The inexhaustible energy of the Fund's team has been visible in all its endeavours so far, for example in numerous training and networking programmes for high potentials from the Balkans. 

"HIJACKED JUSTICE: DEALING

What is the appropriate political response to mass atrocity? In Hijacked Justice, Jelena Subotic traces the design, implementation, and political outcomes of the institutions established to deal with the legacies of violence in the aftermath of the Yugoslav wars. She finds that international efforts to establish accountability for war crimes in the former Yugoslavia have been used to pursue very different local political goals. Responding to international pressures, Serbia, Croatia, and Bosnia have implemented various

mechanisms of "transitional justice"-the systematic addressing of past crimes after conflicts end. Transitional justice in the three countries, however, was guided by ulterior political motives: to get rid of domestic political opponents, to obtain international financial aid, or to gain admission to the European Union. Subotic argues that when transitional justice becomes "hijacked" for such local political strategies, it fosters domestic backlash, deepens political instability, and even creates alternative, politicized versions of history.

The European Fund for the Balkans supported publishing the book in Serbian language.

The policy dialogue was aiming to promote the existing positive examples of leadership and engagement of the Balkan youth through a political forum and present those initiatives to a broader public in Brussels. This event gave the opportunity to present the *VISION OF THE BALKANS AND THE EU* through the eyes of the representatives of *THE NEW GENERATIONS* of the Western Balkans.

The aim of the debate was to strengthen understanding amongst the representatives of the EU institutions and young people and the needs, thoughts and problems they encounter. The debate was hosted by the *European Policy Centre* at which one may influence the policy of the EU as well as of the EU member states and their attitude towards the Western Balkans. The direct and open dialogue inspired both guests and other participants of the event to proactively think about the status of young people in the Balkans, the future of the Balkans and the EU accession.

Conference gathered 50 REPRESENTATIVES OF CIVIL SOCIETY Organizations from Hungary and the Western Balkans **REGION**, representatives of the Ministry for Foreign Affairs of Hungary responsible for realization of the EU Presidency priorities and experts involved in the EU strategy for cooperation in the Danube region.

This Conference aimed to contribute to better COOPERATION AND **COMMUNICATION** between participants and to set a foundation for the fruitful cooperation during the HUNGARIAN PRESIDENCY TO THE EU. Participants discussed objectives and priorities of the future Hungarian EU Presidency and elaborated on the Danube-region strategy. WAVES OF DEMOCRACY

Novi Sad. Serbia 2-8 July 2010

Waves of Democracy is a project run by IUC-Europe and Global Citizen in cooperation with the European Fund for the Balkans and the European Movement Serbia. The European Fund for the Balkans financially supported the Project.

100 YOUNG EUROPEANS from the EU countries and the Western Balkans met in Novi Sad in Serbia to discuss the challenges and possibilities that Western Balkans faces in Europe and in the world. The young students from the Western Balkan countries had an amazing opportunity to meet their peers from the EU countries and in a specific intercultural atmosphere discussed how they can benefit from each other. The overall aim of this gathering was to promote peace and understanding and to give a contribution to a better future for coming generations. Through their participation in this summer school participants became part of an extensive network of young Europeans. They were educated as youth ambassadors and Global Citizen editors and a number of them will be involved in the IUC future activities in the region and in DK.

The summer seminar in Novi Sad included many various lectures, presentations, plenary debates. The overall strategy was the MODEL EUROPEAN PARLIAMENT (MEP concept), which has been developed by students and teachers involved in the MEP sessions. The work was organized in 10 groups and five different committees (1. Energy and Climate Change; 2. Regional Development; 3. Culture and Education; 4. New Media and Democracy; 5. Active Citizenship), which were run by experienced students, who previously participated in the international seminars.

At the end of the summer seminar participants jointly prepared the conclusions and recommendations in form of CITIZENS AGENDA.

In the past several years I have had the opportunity of working and participating in a number of programmes organized by the European Fund for Balkans and I think that through its activities EFB fects three, in my opinion, very important segments of public life which may at present seem modest and even insignificant but the benefits of whose fruition we will experience in the future.

I have taken part in various conferences, workshops, and meetings organized by the European Fund for Balkans. I have always tried to be a participant but several times I found myself in the role of speaker or lecturer and it is through these meetings that EFB performs its first vital function at regional level, that of creating the culture of dialogue. Burdened by past events and the bad decisions of people who are now gone dialogue in the region may be difficult but it is a crucial element in overcoming old and accumulated problems. Since geography is a given and since no one can build a wall around their country, the only thing left to do for us is to talk and events which gather people om the region around the same table, where they discuss their problems and situations are extremely important for our future (both individual and common).

I was very well received at all of these meetings and I used those opportunities to get to know many new people, some of which I have stayed in contact with. The European Fund for Balkans gathers the type of people who will one day, more or less probably, become leaders and decision makers in their countries. When these people meet again at some venue, this time in an official capacity, maybe even as negotiators, the common experiences provided by EFB will undoubtedly help them reach a compromise, a solution, or a common stand more quickly, with less problems, and with greater mutual trust.

Last year I participated in a program whose final phase took place in Brussels, where a number of us discussed in front of two hundred Brussels politicians, diplomats, and journalists the problems and conditions in our countries and our views on Europe and the developments in our countries. I think it's very important that the politicians in Brussels had the opportunity to hear this directly and not tered by our politicians and journalists who all too often embellish their views, and conceal or simply leave out a part of the actual truth.

EUROPEAN STORY FUND

The EUROPEAN STORY FUND is a new and innovative initiative that has been set up by The European Fund for the Balkans* to support the costs of producing stories on relevant European themes by the journalists from throughout the Western Balkans, as well as the journalists based in Brussels, reporting on WB issues. The produced stories are then shared and broadcasted by multiple media houses/TV stations from throughout the Western Balkans. The Fund provides small grants to contribute to the additional costs of making stories for broadcasting on European issues relevant to the countries of the Western Balkans including:

- · How are other Candidate/applicant countries in Western Balkans managing the EU integration processes. How does the negotiation process work?
- How did new EU member states manage key aspects of the EU integration process before they became members? What has it meant for ordinary citizens? What are the cost and benefits of the EU; did EU membership pay off?
- · How do EU member states manage issues like public administration reform, the environment, regional economic development?

The rules of the Story Fund are intended to be as flexible as possible.

- The stories have to cover issues of interest to audiences in the Western Balkans on the European agenda.
- There is no restriction on the content except the basic conventions of professional journalism. Stories have to be interesting and accessible to general audience.
- They can be shown on news programmes, or on current affairs/magazine programmes covering EU/foreign affairs on public or private TV stations in the Western Balkans

BACKGROUND

This initiative aims to improve the public understanding of the European accession process and debate on the EU integration in the Western Balkans. It establishes a flexible co-operative network of working TV journalists from throughout the region, regarded as the best in their field that share their ideas and know how as well as join their resources in the story production and sharing process.

The initiative was initially proposed by the journalists themselves coming from different countries of the Western Balkans. It is an example of locally driven regional co-operation.

INTRODUCTION TO TWO LAUNCH STORIES: SCHENGEN AND VISA ROAD MOVIE

When the European Commission approved the decision to allow citizens of Macedonia, Montenegro and Serbia visa free entry in Schengen countries starting December 2009 – everybody knew what this meant - travel throughout Europe without having to ask for official permission weeks or even months ahead.

As the launch of the European Story Fund closely coincided with the opening of the Schengen doors our journalists picked visa free travel as the obvious theme of their two initial launch stories.

The value of free access to the Schengen zone is obvious to anyone that has had the experience of waiting in line for visas in front of the Schengen country Embassies and Consular offices. However, what is less known is when, by whom and how this idea of "no borders" was initiated. The Schengen story was produced to answer exactly these questions.



The Agreement was signed in 1985, in the village of Schengen located in Luxemburg, across the river from Germany, and about 200 meters upstream from the French territory. It was initiated by Germany and France, while the Benelux countries simply joined the club, all 3 calculating that this would be a deal that would last for a few years only - to temporarily ease communication. Initially signed by only 5 Ministers, the zone now includes a total of 28, and has in the very least outlived its predicted lifespan.

Although finances are a significant factor in ones decision to 'travel or not to travel', in this particular case throughout Europe, for many living in the Western Balkans there is another, perhaps even more important barrier - visas. The youth particularly suffers, as each college student or young adult is asked to produce a stack of documents with each visa application, proving he/she will indeed come back to the country of origin and is not a threat for the working force of any European country.



Thus, when the Schengen borders for Macedonia, Montenegro and Serbia finally opened, some jumped at the chance to explore Europe outside the Western Balkans with less procedures and greater ease.

The Visa Road Movie follows Anton – history student from Skopje, Jasna from Podgorica and Iva from Belgrade both studying at the Serbian language Literature Department as they cross the borders of the European Union for the first time, without visas, on their way to Vienna, Austria. Once in Vienna, they meet with locals their own age, learn about the Austrian education system and of course experience the city atmosphere, food and drinks.

Another quality of the project is that all ideas are examined and verified by the participating journalists themselves, which creates a specific network of professionals focused on covering and explaining Europe to their audiences in various Balkan countries.

It should also be said that the ESF is only at its beginning and should now take its real shape. Its final success will depend on how successfully the heterogeneous group of the participating journalists/media is organized into workable and functioning structure - capable of turning nice ideas into concrete results.

COUNCIL OF EUROPE NETWORK SUPPORTED REGIONAL SEMINARS



The Council of Europe schools of political studies were established to train future generations of political, economic, social and cultural leaders in countries in transition. They run annual courses of seminars and conferences on topics such as European integration, democracy, human rights, the rule of law and globalisation, with the participation of national and international experts.

Today the network includes 16 schools covering the whole of East and South-East Europe and the Caucasus.

The Schools of Political Studies offer a series of one-week seminars in the country, with closing seminars held at the Council of Europe in Strasbourg. Annual seminar cycles are comprised of three to four seminars where domestic and international experts cover topics such as European integration, democracy, human rights, the rule of law and globalization. Seminar participants are young political leaders, local selfgovernment representatives, judges, lawyers, journalists, businessmen/ women and civil activists.




